 - Anne Carlson to initiate Form 1023 to apply for recognition under IRS Code Section 501(c)(3).
 - o Instructions available online; requires historical and financial information.
 - Filing fee is \$600.
 - Application will be retroactively applied upon IRS approval.
 - o Form must be submitted with the church's updated Articles of Incorporation.
 - o Annual filing of Form 990 will be required after recognition.
